APG Members Go to Washington

This week, several APG board members flew to DC to meet with members of Congress and the Administration to share successes in their participation in Medicare Advantage (MA) and discuss CMMI's new models.

The team met with members of Senators Pelosi's and McConnell's office, along with CMS senior staff on Direct Contracting, Primary Care Models, and MA.

Administration

CMS Releases Medicare Advantage Advance Notice Part II and MA Proposed Rule

On February 5, CMS released both the [Part II proposed Rate Notice](#) (comments on the Rate Notices are due March 6) and the [MA proposed rule](#) on policy changes (comments due April 6) to strengthen and modernize the MA and Part D prescription drug programs.

Key Aspects:

- The proposed rate notice is expected to increase the plans' revenue by 0.93 percent as opposed to 2.53 percent in 2020
- Allows beneficiaries to compare their out-of-pocket payments for different prescription drugs through a real time benefit tool
- Expands the use of telehealth in Network Adequacy standards
- CMS describes payment methodology for 2021 MA ESRD populations

Congress

Competing Surprise Billing Legislation

On February 7, the House Education and Labor Committee released their "[Ban Surprise Billing Act](#)" focusing on protecting patients from surprise billing and using median in-network rates and independent dispute resolution for out of network providers for amounts above \$750. The Committee will consider the legislation in a formal markup on Tuesday, February 11. The bill is similar to legislation previously considered by the Energy and Commerce Committee, which is preferred by plans.

The House Ways and Means Committee also decided to move forward with a competing proposal and release their "[Consumer Protections Against Surprise Medical Bills Act of 2020](#)" that would end surprise billing for out of network services and puts protections in place to protect patients. Ways and Means bill outline a two-step process to resolve payment disputes between plans and providers. In an initial 30-day period, both parties would attempt resolution and be required to share certain information. If the two parties cannot reach resolution, they can opt to use a mediated dispute resolution process with an independent arbiter who will consider each party's best offer, along with supporting information, and the contracted rate specific to the plan, and for similar providers, services, and geographic area. Many providers prefer this approach.

Speaker Pelosi has indicated that all House Committees need to conclude Committee action on surprise billing in February. It's expected that providers and plans will be discussing their viewpoints with the various committees this week.

CMMI Guard Rail Proposal

On February 3, Representatives Terri Sewell (D- AL), Adrian Smith (R-NE), Tony Cardenas (D-CA), John Shimkus (R-IL), Brad Wenstrup (R-OH) and Kurt Schrader (D-OR) introduced the "[Strengthening Innovation in Medicare and Medicaid Act](#)" that would limit the CMMI from developing demonstration projects to less than five years and limit participants to a number needed to be statistically valid. As you know, CMMI's mission is to design, test, and implement new healthcare payment models so this legislation has potential to limit their scope.
